Regular Meeting – September 24, 2019 Long Hill Administration Building Lorraine R. Smith Assembly Room

Agenda Item I—Call to Order

The meeting was called to order at 7:00 p.m.

Agenda Item II—Preliminary Business

- A. Pledge of Allegiance The Public Session began with a salute to the Flag.
- B. Recognition Mrs. Lisa Cerulli Trumbull's Teacher of the Year Our 2019-2020 Trumbull Teacher of the Year is Lisa Cerulli. Lisa is an extraordinary educator with a broad range of achievements and impressive qualifications. She will be recognized at the Connecticut Teacher of the Year Ceremony which will be held on December 4, 2019 at the Bushnell Memorial Center in Hartford, Connecticut. State Representatives Laura Devlin and David Rutigliano presented her with a special citation at this evening's meeting during which the Board congratulated Mrs. Cerulli for her outstanding achievement.
- C. Correspondence Ellie Grosso thanked the BOE for adding 3rd and 5th grade sections at FT but is questioning why it took so long and how the BOE makes decisions on how to appropriate money in the education budget; Beth Gilman is asking that the current policy for determining the number of class sections be evaluated to meet efforts to decrease student anxiety and better meet the needs of our students; Lainie McHugh thinks that any search committee formed for the position of Superintendent should include all vested stakeholders; Ruth Fontilla has gathered names of 9 parents who would like to be on the search committee for the new Superintendent.
- D. Public Comments Parent April Lang and two Middlebrook 3rd graders told the Board how hot and overcrowded their classroom is and that there is no space to learn; Tara Figueroa spoke on behalf of 43 Middlebrook parents concerning the 3rd grade class size at Middlebrook and shared documentation on the enrollment history of this class. Mrs. Figueroa cited important rationale to support smaller class size to benefit our students and asked the BOE to address this concern and offer a viable solution to provide equity across the district; Jennifer Mottolese stated that parents must serve on the Superintendent search committee to ensure that Trumbull gets the best candidate; Ellie Grosso thanked the Board for adding class sections at FT and insists that we use allocated funds for needed teachers; Jim Zygmont thanked the Board for adding FT sections and said we must now advocate for our Middlebrook students; in regard to the Superintendent search

committee, Timothy Gallo, would like the community to be involved in this important decision; Ruth Fontilla submitted a list of parents (one from each school) who would like to serve on the Superintendent search committee and feels it should be a national search and Lauren DeLong spoke about the search committee and that teachers voices need to be heard.

- E. Board Chairman Report There was no report at tonight's meeting.
- F. Superintendent Report Dr. Cialfi reported:
 - At the PTSA meeting held on September 24, 2019, Dr. Cialfi explained the significance of the Annual Report that is submitted to the BOE for approval and then to the First Selectman. (This item is on this evening's agenda.) Dr. Budd provided an overview of the strong 2019 Standardized Assessments as well as the Advanced Placement enrollment and scores as per the college approved standard.

Teacher Board Representatives Report Mrs. Rubano reported on the opening days of school and welcomed Dave Erwin to the district; teachers would like to build stronger communication between the BOE and Long Hill Administrators and would like to instill a positive school climate; the TEA is encouraging the BOE to take advantage of the CEA Blitz opportunity. The CEA and the TEA can survey teachers to identify needs within the district. The TEA would like greater transparency in the transfer process of teachers; with Wi-Fi issues and is asking for a completion on an audit addressing security risks for open houses.
