Dear Parents and Staff,

I wanted to share two important updates with all of you regarding our return to in-person learning and our proposed 2021-2022 budget.

Return to In-Person Learning

Our Governor, Commissioner of Education, Department of Public Health, and Dr. Fauci have stated that schools should remain open to the best of their ability during this time. I believe strongly that our students need to have the opportunity for in-person learning to the greatest extent possible. I also want to make sure that we continue to reduce the risk of exposure to COVID-19. To make the most informed decisions possible for the Trumbull Public Schools, I participate in a weekly Zoom call hosted by the State Department of Public Health and State Department of Education. This provides me access to our State level epidemiologists. In addition, I meet with my Reopening Advisory Committee on a weekly basis to review data specific to the Trumbull Public Schools and the Town of Trumbull. I also meet weekly with the PTA Leadership to receive feedback and read all the emails I receive from parents and staff. As you know, on November 13 I chose to close schools for two weeks because of staffing concerns at a few of our schools. The committee requested that I extend the remote learning through December 4 citing concerns about travel and get together over the Thanksgiving break. **This time away from our buildings has resolved all our original staffing issues and, therefore, we will be opening our schools on Monday, December 7 as follows:**

- **Grades PK-5 4 day in-person learning**
- **Grades 6-12 Hybrid Learning model**
- **Distance Learning for all students on Wednesdays**
- **As always, parents have the option to remain in or move to full remote learning**

Moving forward, I do anticipate that staffing concerns could become an issue again. COVID-19 is very contagious and the quarantine guidelines currently in place are very long. With that said, I do not anticipate closing the entire district if some schools are having staffing issues. I may need to close a school or two for a period of time, but not all schools. To reduce the chances that my staff may need to quarantine, I need all parents to be very careful about when they send their child(ren) to school. If your child has any of the [COVID symptoms](#) or had exposure to a positive case outside of school, I need you to keep your child home. We will continue to promote and require all of our mitigation strategies found in our [Reopening Plan](#).


Finally, I do sometimes receive questions about the contact tracing process that we use when cases arise

2021-2022 Budget
